### TEAMS WILL CONSIST OF THREE PLAYERS WHO WILL PLAY FROM SCRATCH

The leading 12 teams will qualify to play in the 7<sup>th</sup> Division Team Championship at the Northcliffe Golf Club on Wednesday 25<sup>th</sup> April 2018. Prizes will be provided by the Union.

Clubs are asked to note that in the Preliminary Round the aggregate of the Handicaps of a Three Man Team should not exceed THIRTY (30) STROKES.

The Clubs eligible to compete are:

- a) Tinsley Park, Todmorden, Hickleton, Sandburn Hall, Doncaster Town Moor, Ganton (These were the relegated teams from the 6<sup>th</sup> Division Team Championship of 2017.)
- b) The First Twelve Teams from the Preliminary Round 2018

**Any Clubs not mentioned above (except the 12 Clubs which remain in each of the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup> & 6<sup>th</sup> Divisions for 2018) may enter for the Preliminary Rounds,** subject to their compliance with the above Handicap Ruling.

Competitors will be granted courtesy of the course as arranged with the Host Clubs and advised in the Instructions for Competitors.

### ENTRY FEE £100 PER TEAM

CLUBS ARE ENTITLED TO ENTER ONE TEAM ONLY

Seventh Division: 36 Holes by Stroke Play – Roger Brook Quaich & Prize Vouchers

Individual Prizes for: Best 36 Hole Score, Best First Round, Best Second Round.

NO COMPETITOR MAY TAKE MORE THAN ONE INDIVIDUAL PRIZE.

No entries will be accepted later than 1<sup>st</sup> March 2018.

**PLEASE NOTE THAT THE ENTRY FEE IS A ONE-OFF PAYMENT. CLUBS GAINING PROMOTION ARE NOT REQUIRED TO PAY AN ADDITIONAL FEE FOR SUBSEQUENT DIVISIONAL CHAMPIONSHIPS.**

## SPECIAL REGULATIONS

1. All Team entries must be made by the Secretary of the competing Club either online or by forwarding the official entry form to THE SECRETARY, YORKSHIRE UNION OF GOLF CLUBS, TO REACH NOT LATER THAN 1<sup>st</sup> MARCH 2018. Entry Fee £90 per TEAM.
2. The Divisional Team Championships will be open to a Club team of Three Players who are members of the said Club, and the Club must be affiliated to the Union. To be eligible to compete in Union Competitions or Matches, a player (a) must be of Amateur Status as defined by the R & A Rules Ltd. It will be obligatory for all Competitors in the Championship to play with a ball that is named on the current R & A List of Conforming Golf Balls. Copies of this list will be available at the course.
3. Competing Clubs will be advised of the draw by post & on the County Website.
4. STARTING TIMES: Rule 6-3 will apply.
5. In the event of a tie or ties in the Preliminary Round, this shall be settled in accordance with the Competitions Rules of the YUGC, i.e. for the last qualifying position, on the Team aggregate for the last 9,6,3 or 1 holes in that order.
6. In the event of a tie in the Seventh Division Team Championship, this shall be settled in accordance with the Competition Rules of the YUGC, i.e. for the first place and the last qualifying position, on the Team aggregate for the last 18, 9, 6, 3 or 1 hole in that order.
7. Ties in the Individual Competition will be decided as follows: For the 36 holes aggregate prize on the last 18, 9, 6, 3 or 1 holes in that order, and for all 18 holes prizes on the last 9, 6, 3, or 1 holes in that order.
8. All disputes relating to the Team Championships shall be referred to the Championship Committee of the YUGC, whose decision shall be final.
9. The Championship shall be played in accordance with the Rules of Golf of R&A Rules Ltd and such Local Rules as shall be approved by the Championship Committee.
10. The decision of the Executive Committee as to the acceptance or refusal of any entry shall be final.
11. A Competitor shall not knowingly make use of any drug to enhance his performance.
12. Members of the Competing Teams will be granted courtesy of the course on the appropriate dates.
13. Subject to the agreement of the Host Club, a competitor will be granted the use of a motorized golf buggy (should one be available) only upon the production of a medical certificate stating disability. Such a vehicle would be for the use of that competitor only.
14. Measuring Devices (Rule 14-3, Appendix 1-A-7, Page 153 and Appendix 1V, Page 181)  
In all Yorkshire Championships, Matches and Meetings, a player may obtain distance information by use of a Distance Measuring device. If during a stipulated round, a player uses this device including a multi-functional device such as a mobile phone) to gauge other conditions that might affect his play (e.g. elevation changes, wind speed etc.) the player is in breach of Rule 14-3. Penalty: Match Play – Loss of hole; Stroke Play Two strokes. Penalty for any subsequent offence: Disqualification.  
This Local Rule applies to team captains in both stroke play and match play Championships. If a team captain uses such a device in breach of this Local Rule, any distance information sought and received by a player from that team captain or given by that team captain and willingly received by a player will result in a breach of Rule 14-3.
