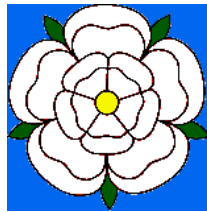

## The Yorkshire Inter-District Union

### Constitution

**1)** The governing body shall be an Executive Committee, designated “The Yorkshire Inter-District Union Committee” consisting of 2 representatives from each constituent Union, together with the Secretary, who shall be appointed by that committee, and a Liaison Officer appointed by the Yorkshire Union of Golf Clubs.

The Chairman of the committee shall be the President of the District Union hosting the Team Championship year by year. The committee shall have powers to delegate all or any of its powers to a sub-committee(s) and have powers to co-opt.

Each constituent Union will have **One** vote when required, the Chairman having the casting vote in the event of a tie for none Constitutional/Rules of Competition items. The Secretary and the Yorkshire Union Liaison Officer are non voting members.

**2)** The constituent District Unions shall be:-

The Bradford & District Union of Golf Clubs (1931)  
The East Riding Union of Golf Clubs (1947)  
The Halifax-Huddersfield & District Union of Golf Clubs (1947)  
The Harrogate & District Union of Golf Clubs (1943)  
The Leeds & District Union of Golf Clubs (1920)  
The Sheffield Union of Golf Clubs (1910)  
The Teesside & District Union of Golf Clubs (1956)  
The York Union of Golf Clubs (1931)

**3)** The Competitions are named as follows:-

The Yorkshire Inter-District Union Team Championship  
The Yorkshire Inter-District Union Junior Team Championship  
The Yorkshire Inter-District Union Golf League  
The Yorkshire Inter-District Union Junior Golf League  
The Yorkshire Inter-District Union Junior Club Team Championship

**4)** Each District Union shall submit on request the names of the players in its team for each Championship. The draws will be made and circulated to the District Unions and the Press at least 7 days beforehand.

**5)** The Secretary will carry out the Draw for each Championship and the League fixtures.

**6)** Each District Union shall be responsible for the Team and Individual Trophies being returned to the Secretary for the Championship on the day of the competition in the following year. (See Rules of Competitions for the names of the Trophies.)

**7)** The Trophies will be insured by the Secretary annually and any defects or damage should be reported to him/her immediately by the holding Union.

**8)** The venues of the Championships shall move in turn from Union to Union. The Junior Team Championship will follow 4 years after the Team Championship. The Junior Club Team Championship will follow 2 years after the Junior Team Championship.

If a Championship is cancelled, the committee is empowered to amend the sequence of championships to allow the effected host Union their turn on the earliest practical date.

**9)** The Union in whose District a Championship is held shall give any assistance required to the Secretary.

**10)** Gratuities decided by the Executive Committee shall be made to the Golf Clubs hosting the Championships. The value of such Gratuities may be increased by the Executive Committee from time to time.

**11)** The Flag of the Y.I.D.U. and/or the host Union shall be flown at each Championship.

**12)** Each Union shall pay a Subscription as decided at the October Annual General Meeting before the start of the following year's fixtures.

**13)** The President and Secretary of the Yorkshire Union of Golf Clubs shall be invited to attend each Championship, along with such other persons as the Executive Committee think fit.

**14)** 6 weeks notice of the intention to propose any new item(s) or alteration(s) shall be given in writing to the Secretary, who shall send notice of the same to every District Union at least 4 weeks before the date of the Annual General Meeting.

**15)** No item in the Constitution or the Rules of Competitions document shall be repealed or altered and no new item(s) added, save by a two thirds majority of those eligible to vote at the Annual General Meeting in October each year.

Exception:- Rules of Golf changes to be automatically amended without delay.

## The Yorkshire Inter-District Union

### Team Championship

#### Competition Rules:

**1)** The Championship shall be decided by Individual Strokeplay over 36 holes, by Teams of 6 players, each Team representing a District Union, with the best 5 players scores in each round to count. The Team returning the lowest aggregate score shall be the winning Team. (See Rule 4 in the event of ties).

**2)** Players for each Team:-

- a)** Must be of Amateur Status as defined by R & A Rules Ltd.
- b)** Must be a Male playing member of a club affiliated to their County & District Union.
- c)** Must have played no less than 3 League Matches for his District Union since the date of the last Championship.
- d)** Must be in possession of a current Competition WHS Handicap.
- e)** Must not have represented any other District Union since the date of the last Championship.

**3)** The format for play shall be 3 ball commencing at an appropriate time agreed by the committee.

**4)** In the event of a tie, the winning Team and Runners Up shall be decided on the 2nd round scores of all 6 players and then the 1st round scores of all 6 players. Should that fail to produce a result, ties shall be decided on the last 9, 6, 3 or 1 holes of the last completed round of all 6 players. If a tie still arises it shall be decided on the last 9, 6, 3 or 1 holes of the first nine holes of the last completed round of all 6 players. If a tie still arises, each of the preceding rounds played shall be treated in the same way (taking each round in the reverse order to that in which they were played) until a decision is reached.

In case of a one round event, ties shall be decided on the last 9, 6, 3 or 1 holes of the round of all 6 players. If a tie still arises it shall be decided on the last 9, 6, 3 or 1 holes of the first nine holes of the round of all 6 players. Should there still be a tie the championship will be shared by all teams tied.

**Note : If a team has no 6<sup>th</sup> individual score to add to the teams aggregate score for both rounds, then that team shall default to losing the tie for that place.**

**5)** Should the start of the first round be delayed, the Championship Committee shall decide the starting time, and tee-off times shall proceed accordingly. In the event of excessive delay, the Championship Committee shall decide the number of holes to be played.

If it is not possible for all Teams to complete at least 18 holes, the Championship shall be abandoned and not replayed.

**6)** The Competition shall be played in according to the Rules of Golf as approved by R & A Rules Ltd, and the Local Rules of the Club upon whose green the event is being played, in so far as they do not contravene the Rules of Golf and have the approval of the Championship Committee.

The Union shall conform to the requirements of the WHS and shall return the scores of all Qualifying Competitions to the Area Authority as appropriate.

**7) Specific Conditions shall apply to the playing of the competition as follows:-**

**a) Team Captains or designated District Union Official present, may place their players in any order of play and have the option to change this order up to **15** minutes prior to each players Tee Off time. The declared order will then remain the same for the second round, unless the Committee authorises or ratifies a change.**

**b) In the event of an injury or other medical condition which incapacitates a player, a substitute will be permitted, provided the Championship Committee are notified of the circumstances before the player's Tee-off time in the first round. The Championship Committee's decision on any substitution shall be final. After this deadline has been reached, no substitutes will be permitted.**

**c) Time of Starting (Note to Rule 5-3a). The time of starting shall be that shown on the Official Draw, or when the player's name is called by the Official Starter, whichever is the later. If a player arrives at his starting point, ready to play, within 5 minutes of his starting time, the penalty for failure to start on time is 2 strokes at the first hole. The penalty for breach of this rule is disqualification.**

Exception : Where the Committee determines that exceptional circumstances have prevented a player from starting on time, there is no penalty.

**d) The Ball (Note to Rule 4-2a). The ball the player uses shall be named on the current List of Conforming Golf Balls issued by R & A Rules Ltd.**

**e) Ride-on Buggies. See appendix I.**

PENALTY FOR BREACH OF CONDITIONS 7c, 7d, 7e, = Disqualification.

**f) Advice. In accordance with the note to Rule 24.4 of the Rules of Golf, each Union may (in addition to the persons from whom advice may be asked under that Rule) appoint one person only from whom advice may be taken by their own team members under that Rule, except when the player's ball lies on the putting green.**

PENALTY FOR BREACH OF RULE 7f = 2 strokes.

**g) Each District Union shall prior to commencement of play advise the Championship Committee as to who, for the purposes of adhering to Rule 7f, the appointed person is.**

**8) All disputes relating to the Competition shall be referred to the Championship Committee acting under the power delegated to it by the Executive Committee, whose decision shall be final.**

Matters of complaint regarding Dress or Behaviour against any player **MUST** be referred from the Host Club to the Host District Union and then to the District Union of the player involved. They must then refer the complaint to the player's Home Club.

**9) The Secretary will make arrangements with the Host Golf Club for courtesy of the course for practice rounds (one per player plus reserve) and for the day of play.**

**10) Trophies - item 6 of the Constitution refers:-**

**a) The Team Championship Plate will be held for 1 year by the winning Team.**

b) The Leeds & District Union Trophy will be held for 1 year by the player recording the lowest aggregate score for 36 holes. The player will also receive a memento.

c) The value of prizes to be awarded will be decided at the Annual Meeting prior to the event, and will conform to the Rules of Amateur Status as published by R & A Rules Ltd.

**Junior Team Championship**

Competition Rules:

**1)** The Championship shall be decided by Individual Strokeplay over 36 holes, by Teams of 6 players, each Team representing a District Union, with the best 5 players scores in each round to count. The Team returning the lowest aggregate score shall be the winning Team. (See Rule 4 in the event of ties).

**2)** Players for each Team:-

- a)** Must be of Amateur Status as defined by R & A Rules Ltd.
- b)** Must be a Male playing member of a club affiliated to their County & District Union.
- c)** Must be under the age of 18 at 00.00 hours on the 1st of January in the year which the competition is to be played.
- d)** Must be in possession of a current competition WHS Handicap.
- e)** Must not have represented any other District Union since the date of the last Championship.
- f)** Must have played in a minimum of 1 Junior League match in the current year and prior to the Championship.

**3)** The format for play shall be 3 ball commencing at an appropriate time agreed by the committee.

**4)** In the event of a tie, the winning Team and Runners Up shall be decided on the 2nd round scores of all 6 players and then the 1st round scores of all 6 players. Should that fail to produce a result, ties shall be decided on the last 9, 6, 3 or 1 holes of the last completed round of all 6 players. If a tie still arises it shall be decided on the last 9, 6, 3 or 1 holes of the first nine holes of the last completed round of all 6 players. If a tie still arises, each of the preceding rounds played shall be treated in the same way (taking each round in the reverse order to that in which they were played) until a decision is reached.

In case of a one round event, ties shall be decided on the last 9, 6, 3 or 1 holes of the round of all 6 players. If a tie still arises it shall be decided on the last 9, 6, 3 or 1 holes of the first nine holes of the round of all 6 players. **8) All disputes relating to the Competition shall be referred to the Championship Committee acting under the power delegated to it by the Executive Committee, whose decision shall be final.**

Matters of complaint regarding Dress or Behaviour against any player **MUST** be referred from the Host Club to the Host District Union and then to the District Union of the player involved. They must then refer the complaint to the player's Home Club.

**9) The Secretary will make arrangements with the Host Golf Club for courtesy of the course for practice rounds (one per player plus reserve) and for the day of play.**

**10) Trophies - item 6 of the Constitution refers:-**

**a)** The Team Championship Salver will be held for 1 year by the winning Team.

**b)** The John Peet Rose Bowl will be held for 1 year by the player recording the lowest aggregate score for 36 holes. The player will also receive a memento.

**c)** Prizes will be awarded to the player's with the best 1st and 2nd round Gross scores, excluding the overall winner.

**d)** The value of prizes to be awarded will be decided at the Annual Meeting prior to the event, and will conform to the Rules of Amateur Status as published by R & A Rules Ltd.

**11)** Caddies are **NOT** allowed.

## The Yorkshire Inter-District Union

### Golf League

#### Competition Rules

- 1)** Eight Teams, one from each District Union, will form the League.
- 2)** Players for each Team:-
  - a)** Must be of Amateur Status as defined by R & A Rules Ltd.
  - b)** Must be a Male playing member of a club affiliated to their County & District Union.
  - c)** Must be in possession of a current Competition WHS Handicap.
  - d)** Must only represent one District Union in any Senior League Season.
- 3)** Each Team will play against every other Team in the League once per season as laid down in the Fixture list.
- 4)** Each team will consist of 12 players for each match, drawn from the member Clubs within their District Union.
- 5)** Each match is to consist of 6 Foursomes in the morning, and 12 Singles matches in the afternoon, all played from Scratch over 18 holes.
- 6)** The Team Captain for each match shall list his Team in playing order before the morning Foursomes, and again before the afternoon Singles, the Team lists shall be exchanged, and the pairings taken accordingly.
- 7)** If a player or players fail to be present at a time fixed for a match, he or they will be recorded as having lost 10 & 8.
- 8)** The 12 players named by the Team Captain on the morning Foursomes match sheet, shall be the only players eligible to play. No substitutes shall be permitted thereafter except from those players and officials present at the Tee-off time of the first Foursomes match.
- 9)** Matches will commence at 10.00 a.m. on the date stipulated, or at a time to be mutually agreed by both Team Captains.
- 10)** All Matches will be played in accordance with the Rules of Golf published by R & A Rules Ltd, and the Local Rules of the Host Club, as approved by the Team Captains, so far as they do not contravene the Rules of Golf.
- 11)** 2 points will be awarded for a win, and 1 point awarded for a half. Thus 36 points will be awarded in total for each match.
- 12)** A decision to cancel a match, prior to it's date, may be taken by the home Team Captain only if he is certain that the course is unfit for play, and if every effort has been made to find an alternative venue.

**13)** A decision to cancel a match before play commences may only be taken by mutual agreement of both Team Captains, in the absence of such agreement the match will take place.

**14)** A decision to abandon a match, once commenced, may only be made by mutual consent of both Team Captains, in the absence of such consent the match will continue.

**15)** As a result of any match which is either cancelled or abandoned before a result is achieved, both teams will be awarded 18 points. In matches which are abandoned after a result is achieved, all incomplete matches will be deemed to be halved.

If start of play is so delayed as to make it impossible to complete the full match, the Team Captains and/or a nominated, non playing member of the District Union executive present may, Rule 4 notwithstanding, decide to play the Singles element of a match only. In such a case all the Foursomes matches will be deemed to be halved.

Where a match is abandoned after the Foursomes have begun and results have been reached, these results shall stand, and all incomplete matches shall be halved.

**16)** Matches which are either cancelled or abandoned will not be replayed.

**17)** At the completion of a match the Team with the most points shall be the winner and will be awarded 2 League points. Should each team have 18 points they will be awarded 1 League point each.

**18)** At the end of the season the Team with the most League points will be the League Champions and will be the holders of the Yorkshire Inter-District Union Golf League Trophy for 1 year. The Trophy will be presented to the President of the winning Union.

Should 2 or more Teams have the same number of League points, then the League Champions will be whichever of those Teams has the most match points. In the event that 2 or more Teams have the same match points, the League Champions will be whichever of those Teams has the greater individual match margins throughout the season.

**19)** The home Team Captain must complete fully and post or e-mail a copy of the match results sheet to the Inter-District Union Secretary without delay, and also telephone him/her with the result as soon as possible after the conclusion of play.

**20)** Specific Conditions shall apply to the playing of the matches as follows:-

**a) The Ball (Note to Rule 4-2a).** The ball the player(s) use(s) shall be named on the current List of Conforming Golf Balls issued by R & A Rules Ltd.

**b) Advice.** In accordance with the note to Rule 24.4 of the Rules of Golf, each Union may (in addition to the persons from whom advice may be asked under that Rule) appoint one person only from whom advice may be taken by their own team members under that Rule, except when the player's ball lies on the putting green.

Each Union shall, prior to commencement of play, advise the other Union as to who, for the purposes of adhering to Rule 20b their appointed person is.

c) Ride-on Buggies. See appendix I.

PENALTY FOR BREACH OF CONDITIONS

20a & 20c = Disqualification, 20b = Loss of hole.

## **The Yorkshire Inter-District Union**

### **Junior Golf League**

#### **Competition Rules**

- 1)** A team from each participating District Union will form the League.
- 2)** Players for each Team:-
  - a)** Must be of Amateur Status as defined by R & A Rules Ltd.
  - b)** Must be a Male playing member of a club affiliated to their County & District Union.
  - c)** Must be under the age of 18 at 00.00 hours on the 1st of January in the year which the competition is to be played.
  - d)** Must be in possession of a current competition WHS Handicap.
  - e)** Must only represent one District Union in any Junior League Season.
- 3)** Each Team will play against every other Team in the League once per season as laid down in the Fixture list.
- 4)** Each team will consist of 12 players for each match, drawn from the member Clubs within their District Union.
- 5)** Each match is to consist of 6 Foursomes in the morning, and 12 Singles matches in the afternoon, all played from Scratch over 18 holes, the singles match pairings being made in playing handicap order.
- 6)** The Junior Organiser for each match shall list his Team in playing order before the morning Foursomes, and again before the afternoon Singles, the Team lists shall be exchanged, and the pairings taken accordingly.
- 7)** If a player or players fail to be present at a time fixed for a match, he or they will be recorded as having lost 10 & 8.
- 8)** The 12 players named by the Junior Organiser on the morning Foursomes match sheet, shall be the only players eligible to play. No substitutes shall be permitted thereafter except from those players and officials present at the Tee-off time of the first Foursomes match.
- 9)** Matches will commence at 10.00 a.m. on the date stipulated, or at a time to be mutually agreed by both Junior Organisers.
- 10)** All Matches will be played in accordance with the Rules of Golf published by R & A Rules Ltd, and the Local Rules of the Host Club, as approved by the Junior Organisers, so far as they do not contravene the Rules of Golf.
- 11)** 2 points will be awarded for a win, and 1 point awarded for a half. Thus 36 points will be awarded in total for each match.
- 12)** A decision to cancel a match, prior to it's date, may be taken by the home Junior Organiser only if he is certain that the course is unfit for play, and if every effort has been made to find an alternative venue.

**13)** A decision to cancel a match before play commences may only be taken by mutual agreement of both Junior Organisers, in the absence of such agreement the match will take place.

**14)** A decision to abandon a match, once commenced, may only be made by mutual consent of both Junior Organisers, in the absence of such consent the match will continue.

**15)** As a result of any match which is either cancelled or abandoned before a result is achieved, both teams will be awarded 18 points. In matches which are abandoned after a result is achieved, all incomplete matches will be deemed to be halved.

If start of play is so delayed as to make it impossible to complete the full match, the Junior Organisers and/or a nominated, non playing member of the District Union executive present may, Rule 4 notwithstanding, decide to play the Singles element of a match only. In such a case all the Foursomes matches will be deemed to be halved.

Where a match is abandoned after the Foursomes have begun and results have been reached, these results shall stand, and all incomplete matches shall be halved.

**16)** Matches which are either cancelled or abandoned due to exceptional circumstances may only be re-arranged with the agreement of the Executive Committee.

**17)** At the completion of a match the Team with the most points shall be the winner and will be awarded 2 League points. Should each team have 18 points they will be awarded 1 League point each.

**18)** At the end of the season the Team with the most League points will be the Junior League Champions and will be the holders of the Yorkshire Inter-District Union Junior Golf League Trophy for 1 year.

Should 2 or more Teams have the same number of League points, then the Junior League Champions will be whichever of those Teams has the most match points. In the event that 2 or more Teams have the same match points, the Junior League Champions will be whichever of those Teams has the greater individual match margins throughout the season.

**19)** The home Team Junior Organiser must complete fully and post or e-mail a copy of the match results sheet to the Inter-District Union Secretary without delay, and also telephone him/her with the result as soon as possible after the conclusion of play.

**20)** Caddies are **NOT** allowed.

**21)** Specific Conditions shall apply to the playing of the matches as follows:-

**a) The Ball (Note to Rule 4-2a).** The ball the player(s) use(s) shall be named on the current List of Conforming Golf Balls issued by R & A Rules Ltd.

**b) Advice.** In accordance with the note to Rule 24.4 of the Rules of Golf, each Union may appoint one person only from whom advice may be taken by their own team members under that Rule, except when the player's ball lies on the putting green.



Each Union shall, prior to commencement of play, advise the other Union as to who, for the purposes of adhering to Rule 21b their appointed person is.

c) Ride-on Buggies. See appendix I.

#### PENALTY FOR BREACH OF CONDITIONS

21a & 21c = Disqualification, 21b = Loss of hole.

**22)** The dates & venues of each seasons Junior League fixtures shall be arranged by the host Union's Junior Organiser and submitted to the Secretary by the 1st day of January, with home & away fixtures alternating year on year.

## **The Yorkshire Inter-District Union**

### **Junior Club Teams Championship**

#### **Competition Rules:**

**1)** The Championship shall be decided by Individual Stableford off handicap over 18 holes, by Club Teams of 3 players, each Club Team representing their own District Union, with the best 2 players points score counting, the third player's points score to count if tied. The Team returning the highest aggregate points score shall be the winning Team and their Club name shall be forwarded to the Yorkshire Union of Golf Clubs for inclusion in the EG Junior Champion Club Tournament.

**2)** Players representing each Team :-

- a)** Must be of Amateur Status as defined by R & A Rules Ltd.
- b)** Must be a Member of an affiliated club in their District Union, and it must be his/her Home Club for handicapping purposes.
- c)** Must be under the age of 18 at 00.00 hours on the 1st of January in the year which the competition is to be played.
- d)** Must not have represented any other District Union Club in competitive events during the current season within the County in which the Club is affiliated.
- e)** Must have been eligible to have competed in either the Boys or Girls County Championship to which the Club is affiliated.

**3)** Each Club team to consist of 3 players, Boys or Girls or both.

Entrants must be in possession of an individual up-to-date Handicap Index under the WHS Rules of Handicapping not exceeding 36.4 (Boys and Girls). A Handicap Index must be issued from a "Golf Club" (as defined in the WHS Rules of Handicapping) that is authorised to use the WHS Rules of Handicapping.

**4)** The format for play shall be 3 ball commencing at an appropriate time agreed by the Championship Committee.

**5)** In the event of a tie after comparison of 3rd cards, the winning Team shall be decided by the point scores taken over the last 9, 6, 3, 1 holes in that order. Thereafter the score for the first 9 holes shall be treated in the same way until a decision is reached. Should the Championship be abandoned the Championship Committee will decide the winners by lot.

**6)** The Competition shall be played in according to the Rules of Golf as approved by R & A Rules Ltd, and the Local Rules of the Club upon whose green the event is being played, in so far as they do not contravene the Rules of Golf and have the approval of the Championship Committee.

The Union shall conform to the requirements of the WHS and shall return the scores of all Qualifying Competitions to the Area Authority as appropriate.

**7)** Specific Conditions shall apply to the playing of the competition as follows:-

- a)** Junior Organisers may place their players in any order of play and have the option to change this order up to **15** minutes prior to each players Tee Off time, providing that order is declared to the Championship Committee.

**b)** In the event of an injury or other medical condition which incapacitates a player, a substitute will be permitted, provided the Championship Committee are notified of the circumstances before the player's Tee-off time. The Championship Committee's decision on any substitution shall be final. After this deadline has been reached, no substitutes will be permitted.

**c)** Time of Starting (Note to Rule 5-3a). The time of starting shall be that shown on the Official Draw, or when the player's name is called by the Official Starter, whichever is the later. If a player arrives at his starting point, ready to play, within 5 minutes of his starting time, the penalty for failure to start on time is a 2 point deduction from the total points scored at the end of the round. The penalty for breach of this rule is disqualification.

Exception : Where the Committee determines that exceptional circumstances have prevented a player from starting on time, there is no penalty.

**d)** The Ball (Note to Rule 4-2a). The ball the player uses shall be named on the current List of Conforming Golf Balls issued by R & A Rules Ltd.

**e)** Suspension of Play due to a Dangerous Situation (Note to Rule 5-7b). When play is suspended by the Committee for a dangerous situation (e.g. Lightning), if the players in a group are between the play of 2 holes, they shall not resume play until the Committee has ordered a resumption of play. If they are in the process of playing a hole, they shall discontinue play immediately and shall not thereafter resume play until the Committee has ordered a resumption of play. The signal for suspension of play shall be one long blast on a Klaxon. The signal for resumption of play shall be 2 short blasts on a Klaxon.

**f)** Ride-on Buggies. See appendix I.

PENALTY FOR BREACH OF CONDITIONS 7c, 7d, 7e, = Disqualification.

**g)** Advice. In accordance with the note to Rule 24.4 of the Rules of Golf, each Union may appoint one person only from whom advice may be taken by their own team members under that Rule, except when the player's ball lies on the putting green.

PENALTY FOR BREACH OF RULE 7g = 2 strokes.

Each District Union shall prior to commencement of play advise the Championship Committee as to who, for the purposes of adhering to Rule 7g, the appointed person is.

**8)** All disputes relating to the Competition shall be referred to the Championship Committee acting under the power delegated to it by the Executive Committee, whose decision shall be final.

Matters of complaint regarding Dress or Behaviour against any player MUST be referred from the Host Club to the Host District Union and then to the District Union of the player involved. They must then refer the complaint to the player's Home Club.

**9)** Trophies - item 6 of the Constitution refers:-

**a)** The Junior Club Team Championship Trophy will be held for 1 year by the winning Team.

b) Prizes will be awarded to players of the winning Team.

c) The value of prizes to be awarded will be decided at the Annual Meeting prior to the event, and will conform to the Rules of Amateur Status as published by R & A Rules Ltd.

10) Caddies are **NOT** allowed.

## **Appendix I.**

### **Use of Ride on Buggies:**

The use of ride on buggies is generally prohibited in competitions. Players should walk at all times unless permission to ride has been given by the Championship Committee. Permission will only be given in exceptional circumstances; application to use a ride on buggy must be made to the Championship Committee in writing who alone may authorise its use.

An application to use a ride on buggy by a person who is disabled within the meaning of the Disability Discrimination Act 1995 must be made by the players District Union and supported by a medical certificate signed by a registered medical practitioner certifying that the player is a disabled person within the meaning of the Act and by reason thereof the player is unable to play Golf without the use of a ride on buggy.

The application to use a ride on buggy must also be accompanied by an appropriate insurance certificate covering the player / buggies use.

Any application to use a ride on buggy will also be subject to the Host Golf Clubs rules for ride on buggies and course condition reference safety.

## **Appendix II.**

### **Dress Code:**

In all Team Championships & League matches, the apparel worn by all Players, Caddies if permitted & Officials must be consistent with the host clubs rules both on the Golf Course and in the Clubhouse.

**(a)** Players found in breach of the code will not be permitted to play and their matches forfeited.

**(b)** Jacket, Collar & Tie are required by all Prize winners at presentations.

## **Appendix III.**

### **Conforming Clubs:**

Non conforming Clubs as listed on the R&A website cannot be used in the Junior or Senior Team Championships. (Penalty for use - Disqualification).

This rule does not apply to League Matches or the Junior Club Championship.

## **Appendix IV.**

### **Practice Rounds:**

Whenever possible, practice rounds for the player's involved in all team championships should be made available on the day prior to the championship.

## **Appendix V.**

### **Starting Times:**

Whenever possible, a two tee start is preferred for both the Junior & Senior Team Championships.

## **Appendix VI.**

### **Distance Measuring Devices:**

“In all Y.I.D.U. Championships and Matches a player may obtain distance information by use of a distance-measuring device. If, during a stipulated round, a player uses a distance-measuring device to gauge or measure other conditions that might affect his play (e.g. elevation changes, wind speed, etc.), the player is in breach of Rule 4-3, for which the penalty is 2 strokes in Strokeplay, loss of hole in Matchplay and then disqualification for a subsequent breach.

(In the event of a breach between the play of 2 holes, the penalty applies at the next hole.

#### **Note:**

A multi-functional device, such as a smartphone or PDA, may be used as a distance measuring device provided it contains a distance measuring application that meets the limitations required in Rule 4-3, (i.e. it must measure distance only). In addition, when the distance measuring application is being used, there must be no other features or applications installed on the device that, if used, would be in breach of the Rules, whether or not they are actually used.

## **Appendix VII.**

### **Suspension of Play to a Dangerous Situation (Note to Rule 5-7b):**

When play is suspended by the Committee for a dangerous situation, if the players in a match or group are between the play of two holes, they must not resume play until the Committee has ordered a resumption of play. If they are in the process of playing a hole, they must discontinue play immediately and not resume play until the Committee has ordered a resumption of play. If a player fails to discontinue play immediately, he/she is disqualified, unless circumstances warrant waiving the penalty.

The signal for suspending play due to a dangerous situation will be one prolonged note of a siren.

A resumption of play will be two short notes of a siren, repeated.

## Yorkshire Inter-District Union

### Fixtures Formula

#### League Matches & Championships:

The dates for the League Matches and Team Championships will be decided approximately 2 years in advance, with account taken of National and County fixtures, and clashes avoided where possible.

The Secretary will approach the Yorkshire Union for assistance, and other bodies as required.

League Matches whenever possible should be arranged within 2 to 3 weeks of each other, and never played in consecutive weeks.

#### Format:

Match 1.	To be played on the 3rd Sunday in May.
Match 2.	To be played on the 2nd Sunday in June.
Match 3.	To be played on the 4th Sunday in June.
Match 4.	To be played on the 2nd Sunday in July.
Match 5.	To be played on the 1st Sunday in August.
Match 6.	To be played on the 3rd Sunday in August.
Match 7.	To be played on the 1st Sunday in September.

The Junior Club Team Championship will be arranged for the 2nd Sunday in July.
